Data protection declaration

1. Responsible for data processing

2. Data collected

The data collected on the www.jagona.ch website are as follows:

- a) data entry by the booking request form
- b) automatic entry of technical data

3. Data security

All data transmissions from the www.jagona.ch site are carried out using SSL encryption (https) in accordance with the current state of technical possibilities. This applies both to page views and to the transmission of form data.

4. Processing of collected data

a) Data entry through the booking request form

The booking request form allows the following data to be entered, which is necessary to process the desired booking request and, if necessary, to draw up a subsequent rental agreement for the desired rental period.

- 1. Name and surname
- 2. Company / Association
- 3. telephone
- 4. Mailing address
- 5. Email address
- 6. Arrival and departure times
- 7. Number of persons (adults and children)
- 8. Reason and context of the stay
- 9. Option concerning the equipment of the house

By sending the contact form, an automatic email is generated from the data entered and sent to the owners. An email generated by the system is also automatically sent to the customer to notify him that his request has been taken care of as soon as possible. The contract as well as a reply email are automatically generated with the data provided by the customer and sent to the owner. After manual verification by the owner, everything is sent to the customer.

By submitting this form, the customer accepts that his/her data will be used to manage his/her reservation and to receive information and communications from Jagona.ch. The

customer may unsubscribe from these communications at any time via a link included in the communications.

The data sent by the customer will not be passed on to third parties. There is also no evaluation of personal data.

b) Automatic technical data capture

Technical data is entered by the system of the site operator (host). The entry of this data is automatic and serves only to monitor the technical functionality and availability of the www.jagona.ch site.

The following technical data is captured:

- 1. Browser type/version used
- 2. Operating system used
- 3. Referrer URL (the previously visited website)
- 4. Host name and IP address of the client's computer
- 5. Date and time of access (request to server)
- 6. names of pages and files viewed
- 7. the amount of data transmitted
- 8. notification of success of the consultation

The technical data collected cannot be attributed to specific persons and is evaluated statistically and anonymously by the hosting provider, insofar as technical supervision or legal provisions so require. After the statutory retention obligation, this data is automatically deleted. This data is treated as strictly confidential, is not passed on and is not accessible to third parties. This data, as well as all data on our www.jagona.ch website, is registered with our web host Infomaniak, whose data protection declaration can be found here.

The www.jagona.ch website does not use cookies or analytics services. There are therefore no statistical collections, nor analyses relating to users or individuals, that could evaluate or influence user behavior.
